CITY OF MONONA NOTICE REGARDING SUBMITTAL OF AN APPLICATION FOR A COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FROM THE IOWA ECONOMIC DEVELOPMENT AUTHORITY (IEDA) FUNDING FOR THE CITY OF MONONA SEWER IMPROVEMENT PROJECT ALONG WITH A COMMUNITY NEEDS ASSESSMENT

The Monona city council intends to submit an application for supplemental CDBG funding for a sewer improvement project for the southwest area of the City of Monona. Due to excessive flow in the sanitary sewer system from stormwater and groundwater inflow and infiltration, the recommended improvements include cured in place lining. The Monona city council will also be discussing the community needs within the city.

The funding application will be submitted on or before April 1, 2022. The project will also be fund-

ed with local matching funds from the Iowa Clean Water State Revolving Loan Fund (SRF) and Monona community residents. The intent of this notice is to provide citizens the opportunity to comment on the proposed project and application prior to submittal.
