LUANA CITY COUNCIL MINUTES OF DECEMBER 3, 2020

Meeting at the Luana Fire Department. Location change due to COVID19 Social Distancing requirements.

The Luana City Council held their regular monthly meeting Thursday, December 3, 2020, at 7:00 pm. with Council Members Lonnie Baade, Todd Olson, Jackie Radloff-Schneider and Luke Steege present. Absent: Brenda Boddicker.

Mayor Jerry Schroeder called meeting to order at 7:00 pm.

Minutes of November meeting were reviewed and approved, with correction of date to December 3, upon a motion by Steege, second by Radloff-Schneider, carried unanimously.

Steege motioned to pay all monthly claims totaling \$18,792.54, Olson second, carried unanimously. Council stated they were not pleased with curb repair Receipts for the month totaled \$28,599.99.

SOOGreen Representative was unable to attend meeting. Topic tabled until next regular council meeting.

Matt Wildman, HRGreen Engineer, informed council of specs on upgraded lagoon system for city. Wildman reiterated that the city would possibly not be able to meet future DNR regulations with PWS in agreement. Engineer suggested a facility plan be put in place and projected construction would possibly not begin until 2022. Steege motioned to approve signing contract with HRGreen for development of facility plan for new lagoon system in the amount of \$26,500, Radloff-Schneider second, carried unanimously. Contract was signed by mayor.

Baade motioned to pass Res. 12-2020 T.O.F. Olson second, carried unanimously.

Council discussed sewer rate increase to aid in needed lagoon upgrade. Discussion was tabled until next regular meeting.

Administrator Humble presented info for computer file backup to replace existing system. Baade motioned to approve backup for \$150.00, Steege second, carried unanimously.

Steege motioned to approve tax abatement request for 107 Country-side Road, Olson second, carried unanimously.

Council discussed budgeted items for FY2022 budget. Fire department requested \$25,000 to be budgeted for replacement of van. PWS requested \$20,000 for seal coating.

Items on boulevard topic tabled. Council discussed broken tree at old city park needing to be cut down. PWS stated he would take care of issue.

Next regular Council meeting will be held January 7, 2021 at 7:00 pm. Mayor Schroeder adjourned the meeting at 8:50 pm.
